Dear Residents, Families and Responsible Parties,

You have received a notice today announcing the re-opening of the dining room and explaining the protocols. We are very excited to welcome all residents back to the dining room and cannot wait to serve you!

As a reminder, there are weekly updates on our website as to the Covid status including recreation, dining and visitation. I wanted to take this opportunity to summarize that information in this memo for your convenience.

Visitation: Indoor visitation will be allowed according to the governor's executive order. The current guidance will allow indoor visitation after a number of factors are met. The one factor we are currently waiting on to fulfill these factors at Lester is the Covid-19 Activity Level Index (CALI) score in Morris County to be at medium risk for 2 consecutive weeks. Once this has been reached and we continue to be Covid free, we will send out protocols for indoor visitation.

Recreation: Due to our Covid free status we have been able to move to Phase 2 of the Governor's Executive Directive. This has enabled us to increase group activities of up to 10 residents per cohort. We are also allowed to let in entertainers. We will be testing entertainers for Covid upon entry.

Beauty Salon: Phase 2 also allows us to begin plans for opening the Beauty Salon. We are finalizing the protocols test to do this safely. Once this has been established you will receive notice of protocols and procedures for making appointments.

I am grateful to be able to inform you of these long awaited and positive changes to center activities. This has not been an easy year for families, residents, and staff. We look forward to welcoming the residents back to increased involvement in the daily life at Lester. We also look forward to welcoming the families indoors!
