Dear Residents, Families, Responsible Parties, and Staff

I am writing to notify that since our last notice went out we had **1** more positive resident case in Assisted Living. We also have 1 new resolved cases. Due to these most recent cases we are still considered to be in outbreak status.

At this time, we will be modifying our activity schedule and meals will be delivered to the apartments at least until Wednesday July 13th. You may still visit your family member, however, we ask that if you are experiencing any symptoms, including flu and cold-like symptoms, please refrain from visiting. Please consider refraining from visiting if you are attending large events for 5 days proceeding. For example: weddings, graduations, BBQ's, bat mitzvahs, etc. I would also like to remind you that it is important that you sign in at the kiosk in the lobby. Not only do we use this for taking your temperature but for contact tracing. **I would also like to remind you that if you choose to visit, you and your loved one *must* wear a mask especially if you walk in the corridors, lobby etc.**

Thank you in advance for understanding that while we are doing our best to control any employee or resident from having COVID-19, it may unfortunately happen on occasion especially after a holiday. Lester Senior living continues to follow and enforce infection control practices and initiatives.

I would also like to ask for your patience. We understand you are concerned for your loved ones, however please understand that our staff is not always in front of their computers or phones as they are up on the floors rounding and caring for your family members, this includes nursing management and administration. They will return your call or email as they are able. If your family member exhibits symptoms or there is a concern, they will reach out to you. If there is not a change in their condition, they will not be calling or emailing you. Thank you for your understanding while we try to manage this situation.
